STATE OF IDAHO CHARTER ADMINISTRATOR CONTRACT ADDENDUM

THIS CONTRACT, made this 27th Day of May, year of 2023, by and between **Alturas International Academy #495** ("the School"), and **Michelle Ball** ("the Administrator").

WITNESSETH:

The Administrator signed a three-year contract terminating June 30, 2024. The Charter School and the Administrator agree to amend section 1 of the contract as follows:

- 1. The District hereby increases the compensation for said Administrator as follows: in the month and day of July 1, year of 2023 through the month and day of June 30, year of **2026**, the base salary shall be one-hundred twenty-four thousand dollars (**\$124,000**) per year, plus any additional annual increments, and such other monetary benefits accorded by the District to employees under contract for this position which may be described in a separate addendum. Said salary shall be paid in equal monthly installments in the amount of \$10,333.33 on the 20th day of each month beginning in July, year of 2023, to June, year of **2026**, inclusive.*
- 2. The School and the Administrator agree to extend the duration of the contract as follows: Replace "for a period of three years (12 months per year), beginning in the month and day of July 1, year of 2021 through the month and day of June 30, year of 2024," with "for a period of five years (12 months per year), beginning in the month and day of July 1, year of 2021 through the month and day of June 30, year of 2026."*

The terms of this Contract shall be subject to amendment and adjustment to conform to the terms of any negotiated agreement between the parties as long as those terms do not conflict with the terms of this Contract.

WITNESSETH:


The Administrator signed a three-year contract terminating June 30, 2024. The Charter School and the Administrator agree to amend section 1 of the contract as follows:
